Loyalty Finance Offers

If you currently own a Nissan you may be eligible for our Loyalty Finance Offers regardless of whether you are part-exchanging your current Nissan or purchasing another Nissan. Your Nissan dealer will be able to provide further details about the offers available but please be aware that should you wish to take advantage of a Loyalty Finance Offer you will need to provide your dealer with a copy of the Vehicle Registration Document (V5C) for your current Nissan.

Nissan British Built Trade in Scheme (NBBTS)

At Nissan, if your car is 7 years old or older you can trade it in and receive a £2000 trade in discount on the on the road price of a new Nissan Micra or a £1000 trade in discount on the on the road price of a new Nissan NOTE.

As the UK's largest producer and exporter of cars, we're proud to be able to help you choose a UK-made replacement: the Nissan Micra or the Nissan NOTE, – both built right here, in our Sunderland plant in the UK. The Nissan British Built Trade-In Scheme (NBBTS) is available on vehicles ordered and registered between 4th August 2010 and 30th September 2010.

How to apply

Your Nissan dealer will do all the paperwork for you. The dealer will check that the vehicle being traded in and the new one being bought qualify under the scheme.

Your old vehicle **MUST**

- Be a passenger car or small van up to 3.5 tonnes first registered new in United Kingdom on or before 29th February 2004
 - Be currently registered with DVLA to the registered keeper making the application

- have a current tax disc and a current MOT certificate or current tax disc and a current Hackney Carriage Licence (if applicable) or current tax disc and a MOT certificate which expired no later than 14 days before the date of placing the order for the relevant vehicle
- Have a UK address on the registration certificate (V5C)
- Have been registered to the keeper of the vehicle continuously for the preceding 12 calendar months before the order date of the new vehicle
- Have valid insurance
- Not be registered on a 'Q' plate
- Not be certain categories of insurance write-off
- Not be subject to any outstanding finance arrangement

Your new vehicle MUST

- Be a Nissan UK-built vehicle (Micra, Micra C+C, NOTE)
- Be registered to the same registered keeper as the registered keeper of the old vehicle
- Have had its Registration fees and Vehicle Excise Duty Paid
- Not be registered as a demo or be a used car

Terms and Conditions

- Under NBBTS there is no obligation to scrap any trade in vehicle
 - New Nissan PIXO is not eligible for the 7+ year trade in scheme because it is not British built. QASHQAI and QASHQAI+2 are also not eligible for the 7+ year trade in scheme.
