## **General**

## **Loyalty Finance Offers**

If you currently own a Nissan you may be eligible for our Loyalty Finance Offers regardless of whether you are part-exchanging your current Nissan or purchasing another Nissan. Your Nissan dealer will be able to provide further details about the offers available but please be aware that should you wish to take advantage of a Loyalty Finance Offer you will need to provide your dealer with a copy of the Vehicle Registration Document (V5C) for your current Nissan. Loyalty Finance Offers are not available in conjunction with the Trade In Plus Scheme.

## **Trade In Plus Scheme**

At Nissan, if your car is 7 years old or older you can trade it in and receive a £1000 trade in discount on the on the road price of a new Nissan Micra or new Nissan NOTE or a £1500 trade in discount on the on the road price of a new Nissan QASHQAI or a new Nissan QASHQAI+2.

### **How to apply**

Your Nissan dealer will do all the paperwork for you. The dealer will check that the vehicle being traded in and the new one being bought qualify under the scheme.

### **Your old vehicle MUST**

- Be a passenger car or small van up to 3.5 tonnes first registered new in United Kingdom on or before 29 February 2004
- Be currently registered with DVLA to the registered keeper making the application

- Have a UK address on the registration certificate (V5C)
- Have been registered to the keeper of the vehicle continuously for the preceding 6 calendar months before the order date of the new vehicle
- Not be subject to any outstanding finance arrangement

**Your new vehicle MUST**

- Be a new Nissan Micra, NOTE, QASHQAI or QASHQAI+2
- Be registered to the same registered keeper as the registered keeper of the old vehicle
- Have had its Registration fees and Vehicle Excise Duty Paid

**Terms and Conditions**

- Vehicles registered under the Trade In Plus Scheme are not eligible for any other consumer offers e.g. they are not eligible for free/low cost servicing, extended RAC cover or low rate finance offers (5.9% HP/PCP, 3.9% HP/PCP or 0% HP). Please check with your dealer for further details
